The IATA Agents Association of Sri Lanka was formed in 1988, as a body to represent the interests of the Sri Lankan Travel Agencies accredited to the International Air Transport Association. IAASL was dissolved as a "COMPANY LIMITED BY GUARANTEE" on the 28th of July 2023 at the Extraordinary General Meeting.

At present the membership consists of 129 Travel Agencies located throughout Sri Lanka. The President, Vice President, and 14 Council Members, which includes the immediate Past President, are elected at an Annual General Meeting to guide the Association on behalf of the General Membership.

The Council meets monthly when industry issues require immediate intervention or the consensus of the General Membership.

Let me conclude on a note of thanks.



JOINT IATA BSP TRAINING FOR TRAVEL AGENTS IN SRI LANKA 2023

On Thursday, May 18, 2023, the Ground Floor Auditorium of the Ceylon Chamber of Commerce witnessed a collaborative effort by the IATA Singapore Regional Office, IATA Agents Association of Sri Lanka (IAASL), and Travel Agents Association of Sri Lanka (TAASL). Together, they organized an 'IATA BSP Training' session tailored for IATA-accredited travel agents. The objective was to engage the Sri Lankan market, enhance skills, and deepen knowledge related to Billing & Settlement Plans (BSP).

The training session proved to be a success, drawing the active participation of 150+ members. Mr. Indrajith Mawarala Vitharana, representing IATA, led the session, ensuring its fruitful outcome and enriching the attendees with valuable insights and expertise.

MATTERS ARISING FROM THE MINUTES

CIVIL AVIATION AUTHORITY (CAA)

In the past year, it has been observed within the industry that there is a scarcity of staff due to the comparatively low salaries offered by travel agencies. Overseas-based companies, offering higher salaries and flexible working hours, have attracted personnel from our industry by providing substantial remuneration and performance-based commissions. To address this concern, suggestions have been made to increase the salaries for our travel agency staff, making it more competitive and thus discouraging attrition to other organizations.

To enable this salary adjustment, it was recognized that travel agencies must first enhance their profitability. In the same vein, discussions centered around certain agents offering ticket sales at minimal margins, impacting overall revenue.

As a response, the IAASL Executive Council sought to introduce a 'Code of Ethics' to regulate such practices and ensure fair compensation for agents, requiring support from the Civil Aviation Authority (CAA) and collaboration with industry associations.

In line with this, efforts were made to encourage travel agencies to join IAASL, reinforcing the importance of membership for license renewal and suggesting collaboration with CAA officials to further regulate the industry. Proposed agenda points for a meeting with the CAA were outlined, addressing licensing concerns, fraudulent activities, international sales, compliance issues, and financial guarantees, showcasing the industry's proactive approach to these matters.

Furthermore, a recent meeting with CAA officials regarding Thai Airways refunds resulted in a circular being disseminated among IAASL members, providing updates on the progress. It was reiterated that maintaining a Civil Aviation License is a mandatory requirement imposed by the Sri Lankan Government for establishing a travel agency, particularly stressing the necessity for this license when applying for an IATA International license.

In conclusion, the industry is actively addressing critical challenges related to staffing, ethical practices, regulatory compliance, and collaboration with regulatory authorities to ensure sustainable growth and maintain high standards of professionalism.

BSP, APJC COUNCIL, AND INDUSTRY ISSUES

During the course of the year, the APJC engaged in discussions and held two meetings, on December 20, 2022, and March 29, 2023, focusing on several key agenda items concerning IATA.org and its operations in Sri Lanka. The points discussed during these meetings were as follows:

- Reduction in IATA Subscription Fee: The APJC raised the proposal for a reduction in the IATA subscription fee.
- Extension of IATA Credit Period: A request was made to extend the IATA credit period to 14 days.
- Inclusion of IATA Certificate: The suggestion was put forth to include the IATA certificate in the IATA subscription fee at no extra charge.

- Direct Debit Systems: Alignment with other countries regarding direct debit systems was discussed.
- CEFT and Banking Transfer Issues: Concerns were expressed regarding CEFT and banking transfer issues.
- ADMs/Debit Notes: Challenges related to reviewing ADMs and debit notes due to the growth in volume were highlighted.
- Voiding Tickets: Procedures and issues regarding voiding tickets were discussed.
- Monthly Voiding Statements: Request for monthly voiding statements to be sent in *LKR*.
- Accessibility of IATA Country Representative: Issues concerning the accessibility of the IATA Country Representative in Sri Lanka were addressed.
- Same-Day Reconciliation for BSP Payments: A request was made for same-day reconciliation for BSP payments.
- Change of Bank for BSP Payments: Proposal to change the bank for BSP payments for enhanced accessibility and services.

During the latest APJC meeting on March 29, 2023, a constructive dialogue took place, demonstrating increased productivity compared to previous sessions. The APJC Representatives raised 12 out of the 14 agenda points, emphasizing concerns about billing issues and delayed payment reflection due to fund crediting mechanisms. IATA.org acknowledged these concerns and pledged to escalate them to IATA Management, proposing a switch from Deutsche Bank to local banks for improved real-time payment processing.

Furthermore, an informative IATA BSP Training session was scheduled on May 18, 2023, aimed at enhancing industry knowledge and compliance. The session garnered significant interest, with an estimated participation of 150+ individuals.

Regarding the 'Cheque' payment method cancellation, a letter was dispatched to Mr. Azhar Azhari, awaiting his response before deciding on potential alternative arrangements. Additionally, challenges were noted concerning the new bank guarantee format, as some banks were hesitant to accept it without certain modifications. Mr. Buddhika Hewawasam offered to address these concerns with IATA.org headquarters if such modifications were required in line with local regulations, as advised during the BSP Training.

In representation of IAASL members, the IAASL Executive Council updated the membership on one of the most important actions regarding the discontinuation of Cheque payments as a valid mode for remitting BSP payments in Sri Lanka. Necessary measures were initiated to appeal to the International Air Transport Association's Area Manager for South Asia, highlighting the member concerns.

IAASL Executive Council then circulated the information to the membership that the initiation of this change has been rescheduled to take effect on the 1st of January 2024 which facilitated IAASL members a six-month window to adequately prepare for the upcoming introduction of the new remittance process.

DIPLOMATIC MISSION/ VISA MATTERS

The procedure for reserving Indian Visa Appointments with IVS was communicated, involving sending a text message to the dedicated WhatsApp number provided by IVS (WhatsApp: 077 955 9936) between 09.00 am-12.00 noon. The message should include the company name and the number of passports for which appointments are requested. This method was circulated among the membership.

Additionally, the IAASL Members were informed of the online visa appointment process, emphasizing the requirement for certification or approval of the IAASL President and Renewed IATA Certification to obtain user credentials for appointment scheduling at the Thai Embassy. The process was detailed, highlighting the need to disregard a specific popup message during registration and the subsequent duration for credential issuance. The importance of addressing any member inquiries regarding the procedure was stressed.

Regarding the Malaysian Embassy's visa application process, it was noted that a single email address can now be used for up to five visa applications, representing an update in their protocol.

AIRLINE MATTERS —

During this time, it was communicated that BSP Cash was operational; however, Singapore Airlines faced inventory challenges. An alternative, NDC, was presented as an option with better inventory but accompanied by various restrictions.

An update from Qatar Airways on February 8, 2023, highlighted key points:

- Finalization of precise office location was pending.
- Staff predominantly worked remotely, affecting reachable contact numbers, but email communication remained accessible to customers.
- *QR* in *Doha* provided a contact number for direct customers.

It was emphasized not to disclose travel agents' ticketing information and to redirect passengers ticketed by travel agents to their respective agents for assistance.

The necessity to maintain equal fares across all agents was stressed to prevent unfair business practices.

Successful courtesy visits were made to Qatar Airways (QR), Emirates (EK), Air India (AI), and Singapore Airlines (SQ). During these visits, IAASL and TAASL collaboration was highlighted, and concerns regarding exclusive private fares for selected agents were raised, emphasizing the importance of equal treatment for all travel agents.

The operational differences among airlines were acknowledged, prompting a call for a unique approach to address industry challenges. The Sri Lankan travel industry's significant market share and it is worth of 135 billion in the country were emphasized. The shift from cash-based transactions to credit-based transactions was discussed, raising concerns about its impact on businesses. Suggestions were made to regulate the industry and provide legal education to travel agents to ensure ethical practices and fair competition.

SECRETARIAL SERVICES

The Ceylon Chamber of Commerce continued to provide Secretarial Services for the Association during the year under review.

AUDIT SERVICES

M/s. Baker Tilly Edirisinghe & Co. was appointed as the auditors of the Association and the audited accounts of the Association for the period under review are attached.

1. Accounting policies

1.1. Corporate Information

The IATA Agents Association of Sri Lanka ("The association") is an affiliated association of the Ceylon Chamber Commerce. The registered office is located at No.50, Nawam Mawatha, Colombo 02.

1.2. Principal activities and nature of operations

The object of the association is to promote and protect the common interests of the members of the association who export product and services to engage in any activity as may be necessary or conductive to the interest or benefit of such exports and to promote high standard probity.

2. Basis of preparation

The financial statements of the Association, have been prepared in accordance with SLFRS for SMEs. They have been prepared under the historical cost basis.

The preparation of financial statements in conformity with the SLFRS for SMEs requires the use of certain critical accounting estimates. It also requires management to exercise its judgment in the process of applying the company's accounting policies. Areas involving a higher degree of judgment or complexity, or areas where assumptions and estimations are significant to the financial statements.

2.1. Statement of Compliance

The statement of financial position, statement of comprehensive income and accumulated fund, statement of cash flows, together with the notes to the financial statements of the Association as at 31 March 2023 and for the year then ended, comply with the Sri Lanka Accounting Standard for SMEs as laid down by the Institute of Chartered Accountants Sri Lanka and the requirement of the Companies Act no. 07 of 2007.

2.2. Functional and presentation currency

The financial statements are presented in Sri Lankan Rupees, which is the association's functional currency.

2.3. Going Concern

The managing committee have made an assessment of the Association's ability to continue as a going concern and they do not intend either to liquidate or to cease operations.

2.4. Approval of financial statements by the Managing Committee

Financial statements for the year ended 31 March 2023, were authorised for the issue by the Managing Committee on 03-October-2023

2.5. Comparative information

The accounting policies set out below have been consistently applied to all periods presented in these financial statements. The previous year's figures and phases have been rearranged wherever necessary to conform current year's presentation.

2.6. Significant Accounting policies

The accounting policies set out below have been applied consistently to all period presented in these financial statements. Certain comparative amounts in the financial statements have been reclassified to conform to the current year's presentation.

2.6.1 - Assets and bases of their valuation

2.6.1.1 - Inventories

Inventories are stated at the lower of cost and net realizable value, net realizable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and selling expenses. The cost includes expenditure incurred in acquiring the inventories and bringing them to their existing location and condition.

2.6.1.2. Investments

Investments comprise of fixed deposits and are recognised amortized cost.

2.6.1.3. Cash and cash equivalents

Cash and cash equivalents comprise cash balances and deposits with maturity of three months or less from the acquisition date that are subject to an insignificant risk of changes in their fair value, and are used by the Association in the management of its short-term commitments.

Cash flow statement

Cash flow statement has been prepared using the indirect method.

2.6.2. Liabilities and provisions

Liabilities are recognized in the balances sheet when there is a present obligation as a result of past events, the settlement of which is expected to result in an outflow of resources embodying economic benefits.

A provision is recognized if, as a result of a past event, the Association has a present legal or constructive obligation that can be estimated reliably, and it is probably that an outflow of economic benefits will be required to settle that obligation.

2.6.3 -Statements of comprehensive income

2.6.3.1 Revenue recognition

a) - Subscription and other income

Income / funds are recognised on cash basis at the point of receiving money to the bank from the source and confirmation received from the other party.

b) - Interest income

Interest income is recognized using the effective interest method.

2.6.3.2. Expenditure recognition

Expenses are recognized in the statements of comprehensive income on the basis of a direct association between the cost incurred and the earning of specific items of income. All the expenditure incurred in the running of the business and in maintaining the property, plant and equipment in a state of efficiency has been charged to income in arriving at the surplus or deficit for the year.

2.6.3.3. Taxation

The liability for the taxation has been computed in accordance with the Inland Revenue Act No. 24 of 2017 and its amendments thereto. Taxation for the current and previous period to the extent unpaid is recognized as a liability in the financial statements. When the amount of taxation already paid in respect of current and prior period exceed the amount due for the excess is recognized as an asset in the financial statements.

2.7. Events occurring after the reporting date

All material post reporting event have been considered, disclosed and adjusted where applicable.

2.8. Commitments and Contingencies

Contingencies are possible assets or obligation that arise from a past event and would be confirmed only on the occurrence or non- occurrence of uncertain future events, which are beyond the association's control. Commitments and contingent liabilities are disclosed in notes to the financial statements.
